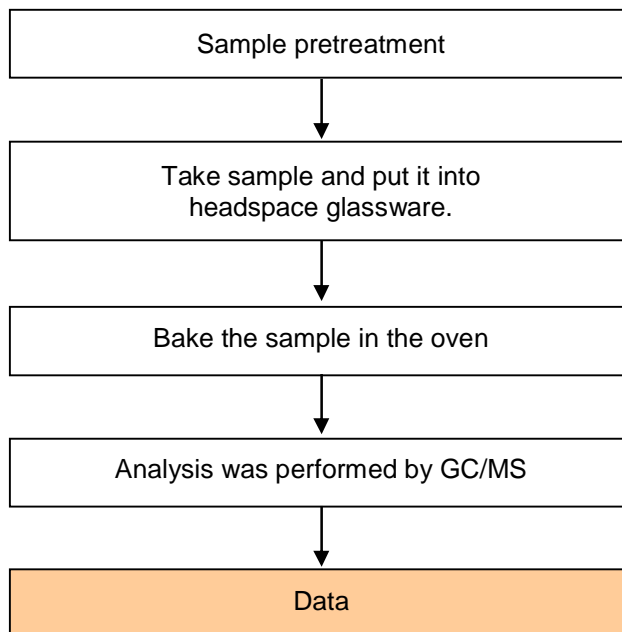

- 3) Name of the person in charge of measurement : Shinjyh Chen



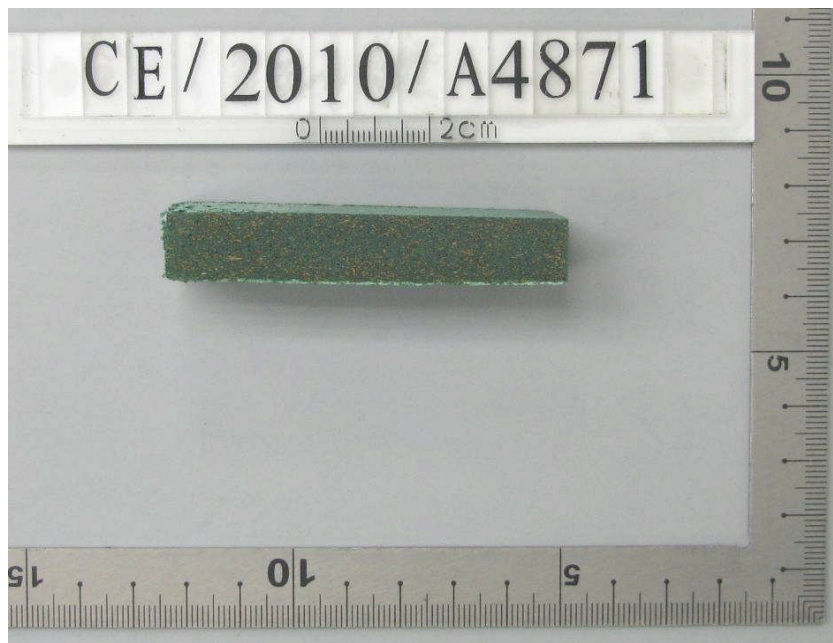
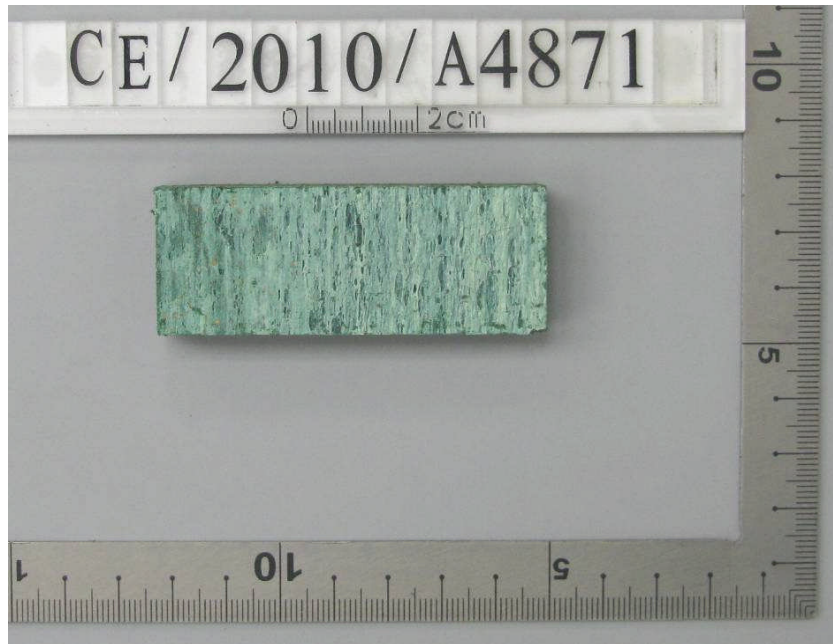
